“Texas Jack n Jill Crappie Classic” Tournament Rules Lake Fork, July 22, 2023

1. Entry Fees, Registration, Payouts

- a. Entry Fees are \$100 per Team.
- b. Entry fees must be received by the Tournament Director no later than 7:00 AM on the day of the tournament.
- c. Entry fees will not be refunded unless the tournament is cancelled or postponed by the Tournament Director.
- d. Teams may register by (i) registering in person at Lakeview Lodge pavilion (2980 FM2946, Emory, TX 75440) on July 21, 2023 between 5pm and 6pm; (ii) completing a Tournament Entry Form and sending the form and entry fees to: Team Reeve, P.O. Box 1398, Athens, TX 75751 (Mailed entries must be received by July 18, 2022); or (iii) registering in person at the pavilion at Lakeview Lodge from 6:00am until 7:00am on the day of the tournament.
- e. 100% of all entry fees will be paid back to the Teams. One place will be paid for every five Teams entered in the tournament (for example, if there are 25 Teams in the tournament, the first 5 places will receive a cash prize). Payouts will be structured in the amounts set forth in the attached payout exhibit

2. Teams

- a. This is a Team tournament. All Teams must be composed of one male angler and one female angler, or two female anglers. One angler can be a junior angler, as long as there is still at least one female on the team.
- b. Teams must fish from a boat with a gasoline powered motor.
- c. Team members must have valid applicable fishing and boating licenses (when required by state law) when participating in the tournament.

3. Weigh-In, Safety

- a. Teams may start fishing (line in the water) anywhere on the lake at 7:00am and must stop fishing (line out of the water) at 1:00pm (“Tournament Hours”). Teams must be in the weigh-in line by 2:00pm. Once the Tournament Director announces that the weigh-in line is closed, no Teams will be allowed to enter the weigh-in line. The weigh-in will be held at the Lakeview Lodge pavilion.
- b. Not more than 7 Legal Crappie that is caught and landed by Team Members on permissible Fishing Tackle, Bait or Lures may be weighed-in and the total weight of the Legal Crappie will determine the order of finish.
- c. A Legal Crappie is any crappie that is caught by a Team Member from a Permitted Fishing Area during the Tournament Hours, does not have any weight enhancements, has not been altered in any manner, was caught in a legal manner, and is legal to be kept by the Team under applicable state law.

- d. Presenting any fish to be weighed-in that is not a Legal Crappie will result in the disqualification of the Team. Exception--If an otherwise Legal Crappie is dead when entering the weigh-in line, the dead crappie will be removed and the Team may continue to the scales for the weigh-in without replacing the dead crappie.
- e. There will be no tie breakers. Ties for awards will be cumulated and split. For example, if there is a tie for 2nd place, the cash prize for second and 3rd place will be combined and split evenly between the Teams.
- f. The Tournament Director may cancel, postpone, delay or shorten the tournament in his or her sole discretion due to extreme weather or water conditions.
- g. Team members must comply with all applicable State and Federal fishing and boating regulations during Tournament Hours.
- h. PFDs must be worn by Team members during Tournament Hours when their boat is on plane.
- i. The use of Boat kill switches is required by law in the state of Texas.
- j. Team members may not use or be under the influence of alcohol or illegal drugs during Tournament Hours.
- k. Team Members must operate their boats in a safe and courteous manner at all times during Tournament Hours.
- l. All Team members must sign a release form prior to participation in the tournament.

4. Permitted Fishing Areas

- a. All areas of Lake Fork.

5. Permissible Fishing Tackle, Bait and Lures

- a. Team members must use rod and reel combos, hand-held pole and reel combos or hand-held poles.
- b. Each Team is limited to not more than 8 poles with not more than 2 baits on each pole in the water at any one time.
- c. Artificial baits and lures are permitted; live bait is permitted.
- d. Landing Nets may be used.

6. Sportsmanship

- a. Unsportsmanlike conduct during Tournament Hours may be grounds for disqualification from the tournament.

7. Violations

- a. A violation of any of these Rules may result in disqualification from the tournament and the forfeiture of any prizes received.
- b. Protests alleging a violation of any of these rules must be made in writing to the Tournament Director within 30 minutes following the end of the weigh-in. All protests must cite the rule number allegedly broken and must be signed by the person making the protest. The person making the protest and the person against whom the protest is being made may be required to submit to and pass a polygraph test or other truth test.
- c. At the request of the Tournament Director, Team members that qualified for a prize at a tournament must submit to and pass a polygraph test or any other truth test deemed necessary to determine compliance with these rules. If a Team

member fails to pass a polygraph test or other truth test, the Team will be disqualified from the tournament and forfeit any prizes received. By participating in this tournament, Team members agree to release Team Reeve, the NOCC and its sponsors from any liability arising from the administration of the test and/or the decisions made as a result of the test.

d. The interpretation of the rules shall be at the sole discretion of the tournament director.
